

MISSIONS COMMITTEE: serves as the coordinator of the Church's Missions and Outreach Ministries. Organize the work of the congregation in outreach and witness. Oversee all on-going church sponsored community programs.

NOMINATING COMMITTEE: identify, evaluate, and nominate qualified persons to fill all vacancies on continuing committees and officers of the church.

PERSONNEL COMMITTEE: review the work of the Pastor on an annual basis. Make recommendations to the Official Board concerning the financial aspects and terms of the Pastor's contracts/covenants, as well as salaries and benefits of all paid personnel.

STEWARDSHIP COMMITTEE: plan the yearly pledge drive

STEWARDS: offer assistance to church family members in crisis, home and hospital visits, assist with funeral receptions of church members with Ladies Guild. Meet with Pastor regularly.

WELCOMING /MEMBERSHIP COMMITTEE: responsible for greeting; recruiting and encouraging persons for membership and fellowship activities.

WORSHIP AND MUSIC COMMITTEE: have oversight in all matters pertaining to the worship services in coordination with the pastor.

ODD JOBS /OPPORTUNITIES TO SERVE – Not covered by committees: Coffee Hour Host, Ushers, Youth Group Leaders, Lay Reader, Finance Assistant, Social Media, Provide rides to church, Open/Close the buildings on Sunday, Funeral Receptions, Acolyte, Choir, etc...

RESPONSIBILITIES of COMMITTEE MEMBERS

BOARD OF TRUSTEES: responsible for all church property & buildings and the general repair, security and maintenance of them. Do not need to be “handy.”

CHRISTIAN EDUCATION COMMITTEE: responsible for overseeing all Christian education programs provided by the church. Includes Sunday School, Library, VBS, Bible studies, retreats, youth groups, Safe Sanctuaries.

CHRISTIAN FELLOWSHIP COMMITTEE: initiate, plan and implement activities, which nurture the participation and interaction of people of the congregation.

ENDOWMENT COMMITTEE: sub-committee of Finance. Administer to the Endowment Funds.

FINANCE COMMITTEE: prepare and maintain the church budget, assist with Stewardship, oversee financial procedures and audits, make financial recommendations to the Official Board.

MEMORIALS COMMITTEE: encourage, receive, record and acknowledge all memorial gifts and artifacts donated to the church. Recommend to Official Board distribution of memorial funds.
